

[WFCCN Receives Status with United Nations](#)

The WFCCN applied for and received affiliation as a Non-Governmental Organization (NGO) with the United Nations (U.N.). This U.N. association demonstrates WFCCN's commitment to the Charter of the U.N., which seeks to achieve international cooperation toward solving humanitarian and health issues. This designation provides WFCCN with the right to appoint a representative to participate in U.N. meetings or in those of the committees and conferences convened under its authority. WFCCN has also applied for consultancy status with the U.N., which required the completion of an extensive application which will be reviewed and voted upon in 2014. Consultancy status with the U.N. would enable WFCCN the rights to consulting and collaborating with the U.N. on issues and processes related to improving world health.

[New Sepsis Guidelines Published](#)

A revised and updated edition of "Surviving Sepsis Campaign: International Guidelines for Management of Severe Sepsis and Septic Shock: 2012" were published in the February 2013 issue journals of *Critical Care Medicine* and *Intensive Care Medicine*. Thirty international professional organizations supported the content of the new guidelines including the World Federation of Critical Care Nurses, which had 2 representatives among the members of the guideline revision taskforce.
